
Contracts Signing

Key dates

“Effective Date” means the later of:

Article 1.39 of RSC

- (a) the **date on which this Contract is executed** by the Parties,
- Or
- (b) if a Lease has already been issued in respect of any part of Contract Area, then the **date on which the said Lease is either transferred to Contractor or a new lease is issued** in the event the Lease cannot be transferred.....

Transfer of Lease



Article 11 of RSC

Transfer of Lease from ONGC/OIL:

- Under Rule-17 of P&NG Rules and Article-11 of RSC
- **Timeline: 60 days** from contract signing date (27th March, 2017)
- If not, existing licence shall be terminated and Contractor shall obtained fresh licence

Standard operating Procedure (SOP)

- SOP given to operators and concerned agencies
- **DGH teams visited state governments** to expedite the process
- Consent letter for all areas received from ONGC/ OIL
- Operator to submit application to State/ MoPNG – 4 applications received

Fresh PML grant

- In Contract Areas with more than One field and different validity
- Contract Areas which include area not held by NOCs

Environment and Forest Clearance



Environmental clearance (EC)



- Operator to submitted **online application to MOEFCC** in prescribed formats and Draft Terms of reference (TOR)
- Intimation of final TOR by MoEFCC
- Operator to submit draft EIA report to SPCB for conducting Public Hearing (PH)
- Final EIA report and PH proceedings to be submitted (online) to MoEFCC
- EC is conveyed after review by Expert Appraisal Committee
- **Time taken from Application to Grant of EC ~ 180 days**

Forest clearance (FC)

- For grant of PML, Forest Clearance (FC) required under section 2(iii) of Forest Act, 1980 if forest land involved

Guarantees



Article 27 of RSC

Bank Guarantee

- To be submitted within **30 days of Effective Date proportionate to PI** in line with Article 27 and Article 5.2 of Contract
- To be addressed to Joint Secretary (Exploration), MoPNG

Financial and performance Guarantee

- **To be submitted within 30 days of Effective Date**
- As per Appendix D-1 & D-2 of RSC

Management Committee (MC)



Article 6 of RSC

Constitution of Management Committee (MC)

- Two (2) representatives of the government
- Two (2) representatives of the Contractor if contractor is single party, or One (1) representative from for each party
- **Timeline: within 30 days** from Effective Date
- 1 Government representative to be Chairman of MC and 2nd designated as Deputy Chairman
- Operator Member to be Secretary of the MC
- Valid Quorum – 1 nominated member from each party

MC functioning

- MC meeting to be initiated at least once every 6 months
- Chairman/ Dy Chairman to preside over the MC meetings, Secretary to prepare and circulate agenda 15 days prior to meeting and minutes within 3 business days of meeting
- MC decisions within maximum 120 days

Management Committee (MC)



Article 6 of RSC

MC approval required

- Annual Program Quantity;
- Development Area demarcated by the Contractor in accordance with this Contract;
- Methodology for measurement of Petroleum;
- Abandonment / Site Restoration plan in accordance with applicable rules/regulations/guidelines of the Government;

MC shall monitor

- Adherence to timelines for Bid Work Programme and additional Work Programme
- Actual Production levels
- Reservoir performance
- FDP and its timelines
- Annual audited statement of Petroleum production, Revenue, and computation of revenue share

Field Development Plan (FDP)



Article 10 of RSC

- FDP to be submitted to MC either individually or jointly for all **Existing Discoveries** within the Contract Area within six (6) months of Effective date
 - Contractor shall not entitled to reduction in Work Programme or modification in economic life
- In case of New discovery in the Contract Area, MC and Government of India to be notified within 7 days
- Development operations to be carried out in accordance with FDP
- Joint development of Existing wells/ Discoveries may be permitted
- Estimated annual potential production to be achieved for each of following 3 years (Program Quantity) to be submitted to MC for review and monitoring


Article 8 of RSC

Technical data of Contract Area

- As per list provided in Information docket
- **Timeline: Data to be requested within 180 days** from Effective Date

Data facilitation

- May be **purchased as per NDR rates** as a test case
- May visit NDR for viewing data available
