Buyer Added Bid Specific Additional Terms and Conditions

1. Buyer Added text based ATC clauses

A.Technical Specifications:

- 1. The Office Software will include desktop versions of Office apps, viz. Outlook, Word, Excel, PowerPoint, One Note, Microsoft Access, Publisher for PC & Microsoft Teams for virtual meetings.
- 2. 1 TB of One Drive cloud storage will be available to each user.
- B.Responsibility of Vendor:
- 1. Adding the user and assigning the license to the old and new users as and when required.
- 2.Software updates/patches released by Microsoft for the product during the subscription period must be provided to DGH unconditionally and free of cost.
- 3. Vendor will have to address all the issues related to M365 and share the RCA/SOP with DGH.
- 4. Any other service/feature added to the product by Microsoft during the subscription period shall be delivered to DGH unconditionally and free of cost.
- 5. Delivery of subscription and its installation in 10 (ten) desktops is to be completed within 7 days after placement of order.

C.Eligibility:

All Microsoft partners are eligible to bid for M365 Business standard edition and will be required to submit current tender specific OEM authorisation as documentary proof.

- 2. Dedicated /toll Free Telephone No. for Service Support : BIDDER/OEM must have Dedicated/toll Free Telephone No. for Service Support.
- 3. Escalation Matrix For Service Support : Bidder/OEM must provide Escalation Matrix of Telephone Numbers for Service Support.
- 4. Successful Bidder can submit the Performance Security in the form of Account Payee Demand Draft also (besides PBG which is allowed as per GeM GTC). DD should be made in favour of DIRECTORATE GENERAL OF HYDROCARBONS payable at NEW DELHI. After award of contract, Successful Bidder can upload scanned copy of the DD in place of PBG and has to ensure delivery of hard copy to the original DD to the Buyer within 15 days of award of contract.
- 5. For fulfilling the experience criteria any one of the following documents may be considered as valid proof for meeting the experience criteria:
 - a. Purchase Order copy along with Invoice(s) with self-certification by the bidder that supplies against the invoices have been executed.
 - b. Execution certificate by client with order value.
 - c. Any other document in support of order execution like Third Party Inspection release note, etc.

Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization. Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specification and / or terms and conditions governing the bid. Any clause incorporated by the Buyer such as demanding Tender Sample, incorporating any clause against the MSME policy and Preference to make in India Policy, mandating any Brand names or Foreign Certification, changing the default time period for Acceptance of material or payment timeline governed by OM of Department of Expenditure shall be null and void and would not be considered part of bid. Further any reference of conditions published on any external site or reference to external documents / clauses shall also be null and void. If any seller has any objection / grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority. While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
