#### 1. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

Taxes, if any may be quoted separately, failing which no amount towards any tax will be paid.

Rates quoted shall be valid for entire period of the contract and no revision of rate will be allowed.

Evaluation of offers will be made based on total price of all items inclusive of all charges, taxes & duties fo r the indicated quantity.

Tenderer should enclose PAN/GST documents.

Contractor would be required to deliver items at his own cost. The quoted rates are inclusive transportatio

n (Loading and Unloading) and freight charges, delivery at DGH, Noida.

The general order shall be supplied within 7 days after the release of the order. Few items under the contract are often required on an urgent supply basis (within 02 working days) for which the contractor must be based in Delhi NCR. With the capability to ensure timely supplies, delay in supply including urgent items will be considered as non-performance of the contract resulting in penalty or termination of the contract.

Estimated annual requirements are projected for evaluation purpose only and lot wise order will be conveyed seperately as per requirement decided by DGH.

In case of calculation mistakes in the submitted bid, unit price will be considered correct and total amount will be corrected at the time of evaluation by evaluating team of DGH

Liquidated Damages: If the Seller fails to deliver any of the ordered quantity within the original specified in the contract, the Buyer will be entitled to deduct/recover the Liquidated Damages for the delay, unless cov ered under Force Majeure conditions aforesaid, @ 0.5% per week or part of the week of delayed period as pre-estimated damages not exceeding 10% of the contract value without any controversy/dispute of any s ort whatsoever.

The Bidder should be well equipped and should have the required i nfrastructure and expertise to undertake the job of supply of Printin g items and must have experience of having successfully executed such orders for supply during the last five (5) years ending Bid Closing Date with the total value of 5.3 Lakhs.

The firm should have experience of supplying Printing Items in Gov ernment Departments /PSUs/OR any other reputed organisations.

The vendor must be based in Delhi/NCR. Self-Certificate/Establishm ent certificate must be enclosed with techno-commercial bid.

Relevant proof of work order/contracts with work completion certificate must be submitted by bidders, else bid will be rejected.

For fulfilling the experience criteria any one of the following docum ents may be considered valid proof for meeting the experience crit eria:

- i. Purchase Order copy along with Invoice(s) with self-certificati on by the bidder that supplies against the invoices have been exec uted.
- ii. Execution certificate by the client with the order value.
- iii. Any other document in support of order execution like Third Part y Inspection release note, etc.

The vendor shall comply with the specification in the mentioned sco pe of work and optional site visit for viewing/inspecting the samples printing items.

#### 5. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

#### 6. Generic

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

#### 7. Past Project Experience

**Proof for Past Experience and Project Experience clause:** For fulfilling the experience criteria any one of the following documents may be considered as valid proof for meeting the experience criteria:a. . After award of contract, Successful Bidder can upload scanned copy of the DD in place of PBG and has to ensure delivery of hard copy to the original DD to the Buyer within 15 days of award of contract.

#### 9. Generic

Without prejudice to Buyer's right to price adjustment by way of discount or any other right or remedy available to Buyer, Buyer may terminate the Contract or any part thereof by a written notice to the Seller, if

i) The Seller fails to comply with any material term of the Contract.

- ii) The Seller informs Buyer of its inability to deliver the Material(s) or any part thereof within the stipulated Delivery Period or such inability otherwise becomes apparent.
- iii) The Seller fails to deliver the Material(s) or any part thereof within the stipulated Delivery Period and/or to replace/rectify any rejected or defective Material(s) promptly.
- iv) The Seller becomes bankrupt or goes into liquidation.
- v) The Seller makes a general assignment for the benefit of creditors.
- vi) A receiver is appointed for any substantial property owned by the Seller.
- vii) The Seller has misrepresented to Buyer, acting on which misrepresentation Buyer has placed the Purchase Order on the Seller.

## Disclaimer/अस्वीकरण

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. Any clause(s) incorporated by the Buyer regarding following shall be treated as null and void and would not be considered as part of bid:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process.
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
